**THE COURT ORDERS THAT:**

1. The defendant (Whyalla Ports) has leave to file and serve the cross-claim in the form annexed to the affidavit of Laura Jane Johns affirmed on 23 April 2025.
2. Golding Contractors Pty Ltd (Golding) has leave to intervene in the form sought in its application to be added as a defendant to the proceeding and it be so added.
3. Each of the plaintiffs and Whyalla Ports are to file and serve short points of claim setting out the basis of their arguments on the claim and cross-claim, and the relief that they seek, by 8 May 2025.
4. Each of the plaintiffs, Whyalla Ports and Golding are to file and serve short points of reply by 14 May 2025.
5. Each of the plaintiffs, Whyalla Ports and Golding are to serve any list of essential documents to be discovered by the others by 15 May 2025.
6. Discovery to be made on the lists of essential documents by 19 May 2025.



7. Any further evidence which any of the plaintiffs, Whyalla Ports and Golding seek to rely on at trial be filed and served by 23 May 2025.
8. Each of the plaintiffs are to file an outline of submissions limited to 20 pages by 26 May 2025.
9. Whyalla Ports and Golding are to file an outline of submissions limited to 20 pages by midday on 30 May 2025.
10. The proceeding be set down for trial on an estimate of 3.5 days commencing on 2 June 2025.
11. Orders 2, 3 and 4 of the orders made by Moshinsky J on 7 April 2025 in this proceeding be vacated.
12. Costs be reserved.
