THE COURT ORDERS THAT:

1. Subject to further order, pursuant to section 90-15 of the *Insolvency Practice Schedule (Corporations)*, being Sch 2 to the *Corporations Act 2001* (Cth) (**Act**), and s 447A(1) of the Act, Part 5.3A of the Act and the *Insolvency Practice Rules (Corporations) 2016* (Cth) (the **IPR**) are to operate in relation to the second plaintiff as if they provided that at any meeting of creditors of the second plaintiff held under Part 5.3A of the Act, each employee of the second plaintiff who is a member of any of the following unions:
 - a. Australian Workers' Union (AWU);
 - b. Automotive, Food, Metals, Engineering, Printing and Kindred Industries Union (AMWU);
 - c. Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia (CEPU); and
 - d. Construction, Forestry and Maritime Employees Union (CFMEU),

is deemed to have duly appointed the person whose name appears in column 2 of Appendix 1 to be their duly appointed attorney pursuant to Rule 75-155 of the IPR, and satisfied the requirement to lodge an instrument as evidence of the appointment of attorney, save for:

- a. any employee who attends such meeting; and



b. any employee who signs a proxy appointing some other person to attend such meeting on their behalf.

2. The costs of the application be paid as costs of the administration.
