A. DETAILS OF APPLICATION

This application is made under sections 439A(6) and 447A of the *Corporations Act 2001* (Cth) (**Corporations Act**) and section 90-20 of the *Insolvency Practice Schedule (Corporations) 2016* (Cth), being Schedule 2 of the *Corporations Act (IPSC)*.

On the facts stated in the supporting affidavit of Lara Luisa Wiggins on 17 March 2025, the First Plaintiffs seek the following orders:

1. An order pursuant to section 439A(6) of the *Corporations Act* that the convening period defined in section 439A(5)(b) of the *Corporations Act* in respect of the Second Plaintiff be extended until 20 March 2026.
2. An order pursuant to section 90-15 of the *IPS* and section 447A(1) of the *Corporations Act* that Part 5.3A of the *Corporations Act* is to operate in relation to the Second Plaintiff such that, notwithstanding section 439A(2) of the *Corporations Act*, the second meeting of the creditors of the Second Plaintiff required under section 439A of the *Corporations Act* may be convened at any time before, or within, five business days after the end of the convening period as extended by paragraph 1 above (provided that the First Plaintiffs give notice of the meeting to eligible creditors of the Second Plaintiff (including the persons claiming to be creditors of the Second Plaintiff) at least five business days before the meeting).
